Dissertation Title: “The Politics of Punishment in the War on Drugs: Race and Racial Language in Policy Shifts”

Dissertation Abstract: In the 1970s the United States government initiated what we call the “War on Drugs.” Soon after, state governments began to enact legislation imposing mandatory minimum sentences for drug offenders, eliminating judicial discretion. The policies resulted in huge rates of incarceration, and disparate impacts for minority offenders. After several years many citizens, politicians, and judges became disenchanted with the harsh laws and called for change. In arguing for reform many cited the costs of incarceration for state budgets, and some criticized the disproportionate nature of mandatory minimum sentences for non-violent offenses, while still others sought to publicize the harsh impacts of the laws on minorities. Notably, however, most who called for reform failed to cite the disparate impacts the policies had on racial minorities as a reason for reform. Instead, reference to race became implicit, and politicians relied on the budget crisis to engage public support and to successfully amend the laws. This dissertation investigates how race continued to be a factor in state and local government policies of the War on Drugs, even though the rhetoric shifted away from explicit references to race toward the budget crisis imposed by the harsh sentencing policies.
